## Supporting evidence:

- 1. Schools are familiar with Sex and relationships education in schools NAfW Circular No 11/2002 and have followed this guidance when developing their policies.
- 2. The national curriculum subject orders and the Personal and social education framework *for 7-19-year olds in Wales* were revised in 2008. It was therefore appropriate to revise *Circular No 11/2002* to reflect the requirements of the revised school curriculum in Wales.
- 3. An advisory group with a practical understanding of the curriculum, and an understanding of the different aspects of discrimination and inequality related to sex and relationships education, was established. The group, comprising a cross-section of teachers across all sectors together with representatives from local authorities and other interested organisations, provided a steer and professional advice during the updating of the guidance circular.
- 4. Officials from the Curriculum Division also worked with colleagues across the Welsh Assembly Government to ensure the accuracy and relevance of the circular and to ensure it was compatible with Inclusive Policy Making requirements.
- 5. The updated guidance circular was made available on the Assembly website and all schools and other stakeholders were invited by letter to feedback.
- 6. All the comments received were analysed. Comments related to equality issues were considered and the guidance amended to address these where practicable.
- 7. An initial IPM screening of the draft guidance circular was completed by Curriculum Division officials.

8. The effect of the online SRE guidance on equality groups will be monitored for any adverse or negative impacts or for further opportunities to promote equality that may emerge. These will be captured and will inform any future development of the guidance. This initial assessment will be reviewed in September 2011.
