## **National Network Conversations and Facilitator Briefing Sessions**

# **Privacy Statement**

In June 2021 the Welsh Government invited practitioners from schools and settings to submit an expression of interest to become involved in the preparation of the National Network Conversations to support the new Curriculum for Wales.

As part of this, the Education Department, part of the Welsh Government, is organising facilitation briefing sessions for practitioners from schools and settings, to support National Network Conversations.

Also the Welsh Government will be recording meetings with practitioners and wider stakeholders which will be made available to practitioners and wider stakeholders at National Network Conversations. The purpose of these recordings is to share case studies, experiences and practices.

Notice of the recordings will be given ahead of the meetings allowing individuals to turn off cameras or to not participate.

### **Recording Facilitator Briefing sessions**

These sessions are being recorded so that colleagues who are unable to attend can have access to the content. The Welsh Government officials leading the briefing sessions will be spotlighted during the recording. Participants are under no obligation to have their cameras switched on during the session. Participants (including their name and/or video or audio feed) may appear in the video if they ask a question. The recordings will be retained for up to 12 months.

Welsh Government will be the data controller for this information and we will process it in line with our public task and the official authority vested in us. The recordings will be shared with all practitioners and regional colleagues who will be facilitating National Network Conversations. The recordings will be uploaded on to the National Network landing page on the Welsh Government's website and on Hwb to promote the National Network.

# Recording meetings with practitioners and wider stakeholders on the new curriculum

Some meetings with practitioners and wider stakeholders will be recorded on case studies, experiences and practices on the new curriculum to share at National Network Conversations. The recordings will be retained for up to 24 months.

As above, the Welsh Government will be the data controller for this information and we will process it in line with our public task and the official authority vested in us. The recordings will be shared with all practitioners and regional colleagues who will

be facilitating National Network Conversations, and will be shared at the National Network Conversations relevant to the meeting. The recordings will be uploaded on to the National Network landing page on the Welsh Government's website and be used in social media to promote the National Network.

Under GDPR, you have the right to:

- Access a copy of your own data;
- Require us to rectify inaccuracies in that data;
- To object to or restrict processing (in certain circumstances);
- For your data to be 'erased' (in certain circumstances); and
- To lodge a complaint with the Information Commissioner's Office (ICO) who is our independent regulator for data protection.
